# **Stapley News - Summer 2005.**

As it may be some years since you applied to the Trust for financial assistance during your postgraduate studies we would like to bring you up-to-date with our news.

#### Selection and Award Procedures used by Council

Application forms are sent out and received during the first three months of the year. The returned application forms are reviewed by the Administrator to ensure that they are complete with academic reference and meet the criteria established by Council. Any doubtful cases are discussed at this point with the Chairman.

All applications are reviewed by at least three members of Council, including the Chairman and Deputy Chairman, using a dual marking scheme.

Applications are graded 1-5 on academic merit taking into account past record, proposed course and the referee's comments. Particular attention is paid to the personal statement by the applicant. A second score (A-D) is based on a student's anticipated financial shortfall in funds during the year for which the application has been made and takes into account student loans, evidence of self-help and financial commitments. Cases for special consideration are earmarked for discussion at the May Council meeting.

The independent scores are forwarded to the Administrator who averages them and organises the Council meeting at which awards are made. No application is rejected without a full discussion at the meeting. The level of individual awards may be modulated to keep them within the overall budget.

Since 1993 Council has been grateful to GlaxoSmithKline for a generous annual grant, which has been regularly increased, to support health-care and, more recently, medical students. It also administers Victor Ford and Judith Mathews Scholarships based on earmarked bequests and endowments. These are awarded on academic merit in keeping with the donors' wishes. Award letters are sent out in June and are followed by a cheque when attendance on the course, and a continuing shortfall in funds, is confirmed.

#### **Financial Issues**

The Trust was established in 1919 based on an endowment by Sir Richard Stapley. Currently the value of the endowment is approximately £3,000,000 invested in charity-based funds yielding approximately £150,000 per annum for distribution as grants and scholarships. This amount includes the £20,000 currently granted each year by GlaxoSmithKline., In 2004 the amount was less because of the adverse financial climate.

In 2005, because of the annual increase in the number of applications and Council's wish to increase the value of individual awards, Council advertised that it would only consider the first 350 applications received. This was successful in limiting the number of applicants from 369 in 2004 to 280 in 2005.

The table below lists the number and level of grants awarded in 2004 and 2005 and shows that both the level of individual awards and total amount awarded increased in 2005.

The Trust is very keen to further increase the level of awards it is able to make. With the decision by Chancellor Brown to remove the tax relief on our dividends, the income of the Trust fell by 20%. We have, however, been able to maintain the level of grants by moving funds to high interest, rather than capital enhancing, investments. The Trust has always striven to minimise over-head costs and Council members do not receive any payment for their services other than essential travel costs. The financial pressure on students with increasing University fees, top-up fees and other charges is becoming intolerable and several students were unable to take up their University offers for financial reasons alone. Some students are incurring debts of up to  $\pounds100,000$  on graduation. This is a particular problem for the graduate entry schemes into the medical, veterinary and allied health-care professions.

The Trust had a particularly successful 75th Anniversary appeal and bequests and donations, including Gift-Aid, have allowed us to increase the level of awards. If alumni are able to make donations to the Trust, however small, these are most valuable. Bequests can be linked to particular areas of educational interest including medicine, veterinary medicine, the performing arts, environmental sciences, research degrees, etc. and offer an opportunity to establish a named award. Where this has been done the successful student is encouraged to maintain contact with the donor with regular progress reports.

**PROFESSOR HRV ARNSTEIN -** Professor Henry Arnstein joined Council in November 1983 at the invitation of his colleague at King's College, London, Professor George Brownlee. George Brownlee's contribution to the Trust as Bursar and Chairman is recorded in the History of the Trust (free copies available from the Administrator). Henry Arnstein was to serve with the same dedication until 2004. As Chairman (1988-2004) he was responsible for steering the Trust through challenging times.



There was a surge in applications in the 1980s and an urgent need to increase income. Council was led to consider the most effective use of its limited resources. Postgraduate students in financial need for second degree courses were identified as those most in need. It then became necessary to increase grants for these students to a realistic level, and to provide for the loss of income which the phasing out of tax credits for charities by the Government would bring at the

turn of the century. This led the Chairman to commit the Trust to three appeals for funds : a pilot one in 1991 to medical and veterinary alumni, followed by a major 75 th Anniversary Appeal in 1994. Professor Timothy Peters and Professor Arnstein personally approached nine distinguished academics to be Patrons of the Appeal, and the Chairman 'topped and tailed' one thousand two hundred letters to trusts, companies and alumni. Over £57,000 was raised, the income from which was available to raise the level of grants. A smaller Millennium Appeal to alumni was launched in 2000 – also the initiative of the Chairman.

In the last years of his Chairmanship, Council revised the management structure of the Trust to provide for greater continuity and a broader range of academic experience within Council. These measures have guaranteed that the Trust is well equipped to fulfil its mission statement of "working to support excellence in the postgraduate education of mature students" in the 21 st century.

The above initiatives were achieved by his wise and patient Chairmanship of Council. There has, throughout his connection with the Trust, been a less obvious aspect of his contributions. As Professor of Biochemistry and Dean of Life Sciences at King's in the 1980s he had had several years of experiencing the aspirations and anxieties of students, and he brought this sensitivity to the consideration of all applications. Both Michael Bushby and Christine Ford knew that Henry was ready at any time to discuss on the 'phone a student whose application troubled them. He loved reading letters from alumni and, with Council, rejoiced in their academic successes and their career developments. One experience which meant a lot to him was to have the privilege of being present when an alumnus received his Masters degree in prison. Applicants and alumni were not mere names to him, and it gave him great pleasure that three alumni – representatives of the thousands of students whom the Trust had assisted during his time – were able to attend a lunch to mark his retirement in November, 2004.

Henry Arnstein served the Trust with tireless and unselfish devotion and we all know that he will continue to have its affairs close to his heart.
